NHIDCL(National Highways Infrastructure & Development Corporation Limited) and M/s. U.P. State Bridge Corporation Limited (hereinafter referred as "the EPC Contractor") signed an EPC Agreement on the 28th October 2020 for the work of "Construction of 2-Laning with Paved Shoulder of New Greenfield Alignment from Chochenpheri at Km 52+000 to Helipad near Menla at Km 82+000 of Rhenock - Menla Spur (NH-717B) Package-IIIA on EPC Basis under SARDP-NE Phase 'A' in the State of Sikkim", with construction period of 36(Thirty Six) Months commencing from the Appointed date. The Appointed date for the project was fixed as 10th December' 2020.

2. As per the Clause 10.3.(i) of EPC Contract Agreement, the EPC Contractor shall construct the project highway as specified in Schedule-B and Schedule-C, and in conformity with the specifications and standards set forth in schedule-D and in accordance with the schedule set forth in schedule-J. As per the Schedule-J of the Contract Agreement the construction of the project was to be completed in all aspects within 36 months from the Appointed Date. In the instant case, the Appointed Date was declared as 10.12.2020, meaning thereby that the EPC Contractor was obliged to complete the construction as per schedule & revised milestone date by 09.12.2023 & 05.09.2024 respectively and accordingly the Milestones date falls on along with targeted financial progress (%) as per Schedule-J are furnished below:

3. WHEREAS, the progress of work has been dismal since start of the project and the EPC Contractor has able to achieve Physical Progress of 28.94% only as on 19.11.2023, against desired progress of 39.67% as per their own revised work programme. Further to mention that the EPC contractor had already been provided the required hindrance free land in

June 2022 to execute the work. In spite of it due to lack of resources and improper planning the progress could not be achieved despite of several Notices issued by Authority's Engineer and Authority. The land required for executing balance work was 14.43 km which was available.

4. WHEREAS, the EPC Contractor has not taken the critical activity seriously. As per provision of Schedule-J, the EPC Contractor must start the work on all viaducts prior to completion of Milestone-II. However, the EPC Contractor has taken up work only in 3 out of 24 nos. viaduct work as on date.

5. WHEREAS, Design & Drawing of 3.340Km (3 nos.) out of 4.470 Km (24 nos). of viaducts are still pending with the Contractor. It has become evidently clear that the Contractor has failed to comply the directions of Authority regularly and has resorted to only giving false assurances. The EPC Contractor was provided 18 km of hindrance free land between km 52 to Km 67 and Km 79 to Km 82 after cutting of trees in the month of June 2022, wherein 18 viaducts were to be constructed. Nevertheless, the design and drawing of these viaducts were submitted by EPC contractor only in Jan- May 2023. This shows that the EPC contractor failed to submit the required design and drawing within 90 days of providing hindrance free land as per the clause 10.2(iv) (h) of CA.

6. The EPC Contractor has failed to achieve the progress as per its own work program. The status of the physical & financial progress is tabulated below from the appointed date till 28.11.2023: -

9. WHEREAS, PMU-Rhenock vide letter ref. (xliii) has issued a Show Cause Notice to declare the EPC Contractor i.e., M/s U.P. State Bridge Corporation Limited, as "Non-Performer", in light of the provisions stipulated in and applicable law of Contract Agreement by giving 15 days' time to furnish its written explanation.

10. WHEREAS, the EPC Contractor vide letter ref. (xli) has furnished their written explanation and the reply of the EPC Contractor was found not satisfactory.

11. Therefore, a personal hearing was offered to the EPC Contractor vide letter ref. (xxiii & xxiv) at NHIDCL, RO-Gangtok in accordance to MoRTH Circular dated 06.10.2021. Vide Conference meeting regarding personal hearing was conducted on 03.05.2023 under the chairmanship of ED(P), RO-Gangtok to review the progress of work. In the personal hearing meeting, several issues were discussed and directions/targets were given to the EPC Contractor, vide OM No. NHIDCL/RO-SKM/Rhenock-Menla/Pkg-IIIA/2023/132 dated 08.05.2023 (referred at above (xxii)). Nonetheless, none of the directions/targets were

fulfilled by the EPC Contractor and it has failed to expedite the progress of work. The directions & status of work as on 07.11.2023 submitted is tabulated below: -

RMC, 01 no. of BSM/WMM plant and 01 no. for the project work, which is insufficient to complete the project work in stipulated time frame. Further, PMU-Rhenock has already provided the requisite documents required for blasting permission to the EPC Contractor vide letter no.550 dated 28.11.2022. However, the EPC Contractor has failed to procure the necessary permission till date for the stretch between km 52+000 to km 72+000. Therefore, the EPC Contractor has failed to perform due to continuous mismanagement, own failures, lack of planning and resources of the work.

13. MD, NHIDCL reviewed the progress of the project fortnightly. In all such meetings dated 20.10.2023, 21.09.2023, 17.08.2023, 13.07.2023, 13.06.2023, 04.05.2023, 06.04.2023, 16.02.2023, 19.01.2023, 15.12.2022, 17.10.2022, 20.09.2022, 14.09.2022, 16.07.2022, 09.07.2022, 16.08.2022, 31.05.2022, 10.03.2022, 02.02.2022, 21.01.2022, 08.12.2021, 04.08.2021, 25.08.2021, 26.10.2021, 08.12.2021, 01.11.2021, 22.06.2021 and EPC Contractor had committed to mobilize the adequate resources in the project and shall achieve the targets of various work activities. However, inadequate mobilization of resources is not a single target could be achieved by EPC Contractor.

14. WHEREAS, ED (P) & GM (P) has regularly visited the site to monitoring the progress of the project work issued letter ref. (vii, ix, xvi, xxi, xxxi, xxxv, xxxviii) to increase the progress of the work. However, the progress of work has been dismal, and the contractor has been able to achieve only 21.37 % financial progress as on date. This raises justifiable doubts in the mind of the Authority about the seriousness of the EPC Contractor.

15. The EPC Contractor has not taken advantage of good working season in the region due to poor planning, mobilization of resources, material & manpower at project site. This lackadaisical approach of the EPC Contractor leads to poor progress of the project work. No external factor has substantiated the poor progress of the project work.

16. WHEREAS, the EPC Contractor, M/s U.P. State Bridge Corporation Limited has found to be defaulted in fulfilling their obligations per the details given below:-

18. WHEREAS, the EPC Contractor was found to be in default in following aspects as per MORTH circular dated 06.10.2021:

19. All the earlier letters/correspondence /notices issued by the Authority to the EPC Contractor for improving its performance may be referred as part and parcel of this order however, the EPC Contractor has not taken any action for improving their performance and also failed to adequate manpower and machineries.

20. NOW, it is quite apparent and certain that the EPC Contractor has failed to uphold its contractual obligations as per the Contract Agreement, had caused detrimental effect on the projects under it has failed to perform the duties in an efficient manner, consistent with the highest standards of professional integrity and Good Industry Practice.

21. THEREFORE, in light of the aforesaid facts and circumstances, considering the nonprofessional attitude of M/s U.P. State Bridge Corporation Limited and aforesaid contractual defaults, breaches, and wilful non-performance in fulfilment of Contractor's obligations as per the provisions of the Contract Agreement and blaming the Authority for its own accountabilities the National Highways & Infrastructure Development Corporation Limited (Authority) is hereby declaring the EPC Contractor M/s U.P. State Bridge Corporation Limited as "Non-Performer" in National Highways and centrally sponsored road projects as per MORTH circular dated 06.10.2021 and in line with the NHIDCL HQ office order dated 05.09.2023 till the completion of the project.

22. In para 8 of MoRT&H Circular no. RW/NH-33044/76/2021 S&R (P&B), dated 06.10.2021, "Upon Declaration of Non-Performer, the Contractor will not be able to participate in any bid with MORT&H or its executing agencies, till such time the Contractor is removed from the list of Non-Performers or the debarment persists. The Contractor shall include its JV partners, promoters whose credentials were considered while qualifying them for the project. Non-Performer/ debarment status of a bidder on the bid-due date will be the criteria for eligibility of a bidder to participate the said bid".
