3. All Correspondence pertaining to RTI may be addressed by name to the above-mentioned officers in future. RTI Applications seeking information in respect of more than one CPIO at HQ/PMU shall be dealt with as under:

(i) GM (Coord) shall handle RTIs concerned to more than one Division, compile all technical related information and send to the applicant, under intimation to DGM (Admin) at HQ.

(ii) In the absence of CPIO in any PMU, the CPIO of the concerned RO shall act as CPIO.

4. Upon transfer from one division to other division or upon assignment of additional Div/Work, the concerned officer will be deemed CPIO for that Div/Work.
