Annexure-I

Eligibility Criteria & proposed Remuneration for Young Legal Professionals

**Eligibility Criteria**

- (i) LLB Degree from National Law University/ National Law Schools or other National Institutes of equal repute on the basis of their LLM CLAT scores.
- (ii) Experience in Legal matters on contractual matters/ arbitration/ legislative matters/ land acquisition etc., will be given added weightage and preference.
- (iii) The maximum age limit shall be 35 years at the time of applying for the post.
- (iv) The remuneration payable to selected Young Legal Professionals would be as under:

Sl. No.	Category	Remuneration
(a)	For fresh Law Graduates out of National Law University/ National Law Schools etc. with LLM CLAT scores	Rs. 35,000/- per month
(b)	For Candidates with 01 to 02 years of experience.	Rs. 55,000/- per month
(c)	For Candidates with 03 to 04 years of experience or more.	Rs. 60,000/- per month

The remuneration will be enhanced by 5% for the successive years, limited to the maximum period of three years.
