7. To participate in bidding process, bidders have to get (DSC) "Digital Signature Certificate" as per Information Technology Act-2000, to participate in online bidding. This certificate will be required for digitally signing the bid. Bidder can get above mentioned digital certificate from any approved vendors. The Bidder, who already possess valid (DSC) "Digital Signature Certificate" need not to procure new Digital Signature Certificate.

8. The bidders have to submit their bids online in electronic format with Digital Signature. The bid cannot be uploaded without Digital Signature.

Therefore, no claim whatsoever from any of the selected bidders on this account shall be entertained in this regard.

23. No Extension of Time shall be entertained in any circumstances.

24. **Make in India- As per policy of Govt. of India to promote Make in India, the provisions vide order no. P-45021/2/2017-B. E-II dated 15.06.2017 on the subject "Public procurement (preference to Make in India)" shall be applicable to the extent possible.**
