#### NOTICE INVITING TENDER (NIT)

1. NHIDCL has been assigned the work of Consultancy Services for preparation of Detailed Project Report and for Pre- Construction activities towards “Construction of Twin Tube Uni-directional Tunnel (102+800 to 106+700 km = 3.9km, 118+850 to 119+530 = 0.68km & 133+900 to 135+380 = 1.48km) of Mawlyngkhung-Mawrngrkreng-Jowai-Ratachera section of NH-06 in the State of Meghalaya.” (as per Annexure-I).
2. Proposals are hereby invited from eligible Consultants who meet the guidelines contained in Public Procurement (Preference to Make in India) Order, 2017 (amended on 16.09.2020) for preparation of Detailed Project Report of Consultancy Services for preparation of Detailed Project Report and for Pre-Construction activities towards “Construction of Twin Tube Uni-directional Tunnel (102+800 to 106+700 km = 3.9km, 118+850 to 119+530 = 0.68km & 133+900 to 135+380 = 1.48km) of Mawlyngkhung-Mawrngrkreng-Jowai-Ratachera section of NH-06 in the State of Meghalaya”. Consultant submitting Proposal in sole capacity or as a member of joint venture or as an associate shall meet the guidelines contained in Public Procurement (Preference to Make in India) Order, 2017 (amended on 16.09.2020). The Letter of Invitation (LOI) and Terms of Reference (ToR) including Request for Proposal (RFP) is available online on e-tender portal of <https://eprocure.gov.in>. The document can also be downloaded from <Agency Website>. Cost of the Document in the form of a Non-refundable document fee of Rs.5,000 (Rupees Five Thousand only) must be submitted in NHIDCL account online at the time of Submission of Bid proposal, specifying the tender id and bid due date.
3. The RFP has also been uploaded on “INFRACON” ([www.infracon.nic.in](http://www.infracon.nic.in)). As such before submitting the proposal the Consultant shall mandatorily register and enlist themselves (the firm and all key personnel), on the MoRTH portal “INFRACON” and furnish registration details along with its RFP. A copy of Infracon Operation Procedure is also enclosed for bidder’s reference.
4. All the bidders registered on Infracon shall form a Team on Infracon and which would be assigned unique Infracon Team ID. Bidders while submitting the proposal shall quote the Infracon Team ID.
5. Bid must be submitted online at e-tender portal of NHIDCL <https://eprocure.gov.in> on or before <1500hrs, 19.08.2024>.
