- 3. The Scope of Work includes the rectification of black spot locations and and carrying out other works as specified in the bid documents.

To participate in the in the bidding, it is mandatory for the Bidders to get registered their firm with e-procurement portal <a href="https://eprocure.gov.in/eprocure/app">https://eprocure.gov.in/eprocure/app</a> to have user ID & password which has to be obtained free of cost. Following may kindly be noted:
  - a. Registration with e-procurement portal should be valid at least up to the date of submission of BID.
  - b. BIDs can be submitted only during the validity of registration.

The Bidders shall update their project and other details on the portal on a regular basis and apply to the tenders via the portal.

- 7. The authorized signatory holding Power of Attorney shall only be the Digital Signatory. In case authorized signatory holding Power of Attorney and Digital Signatory are not the same, the bid shall be considered non-responsive.

Bidder must submit its Financial Bid and Technical Bid on CPPP e-procurement portal within the above deadline. However, such representatives shall be allowed to attend the opening of the bids only if they produce letter of authority on the letterhead of the bidder, at the time of opening of bids as mentioned above.

The amount of Bid Security/Earnest Money is 5.00 Lakh. to be submitted in the form of e-Bank Guarantee/Demand Draft/Bankers Cheque/FDR /NEFT/RTGS in favour of NHIDCL payable at Shillong, in Project Account of RO Shillong as mentioned below (any other form will not be acceptable) of any scheduled commercial bank approved by RBI having a net worth of not less than Rs.500 crores as per the latest annual report of the bank and must be in the name of the Employer. In case of foreign bank (issued by a branch in India) the net worth in respect of the Indian operations shall only be taken into account. It shall be valid for 45 days beyond the validity of the bid. Any bid having bid security for lesser value and shorter validity period shall be treated as non-responsive. Any Bid not accompanied by Bid Security shall also be treated as NON-RESPONSIVE.
