OFFICE ORDER

Subject: Withdrawal of the name of M/s Oasis Projects Limited from the list of "Non-Performers"

The National Highways & Infrastructure Development Corporation Limited (NHIDCL) vide Office Order no NHIDCL/Nagaland/D-K/BW/PKG3/2021/1306 dated 10th August 2022 declared the EPC Contractor, M/s Oasis Projects Limited as "Non-Performer", thereby disabling M/s Oasis Projects Limited from participating in any bid of NHIDCL till such time the EPC Contractor is not removed from the list of "Non-Performers".

2. In this regard, the Hon'ble High Court of Delhi vide Judgment dated 10.04.2024 in the case titled as M/s Oasis Project Ltd V/s NHIDCL having case no ARB.A.(COMM) 39/2023, has pronounced that "The Appellant shall not be treated as non performer or a debarred entity. The said declaration on the website of the NHIDCL shall also be removed within a week". The Judgment Order pronounced also mentions that "The above shall, however, be subject to the final decision in the arbitral proceedings on the question of non-performance, breach, illegality and validity of termination etc. The present judgment would not affect the final adjudication in the arbitral proceedings. Depending on the findings on the issue of breach and termination in the arbitral proceedings, the decision on debarment shall be taken by the Ld. Sole Arbitrator".

3. In compliance to the aforementioned Judgment dated 10.04.2024 passed by Hon'ble High Court of Delhi, National Highways & Infrastructure Development Corporation Limited (NHIDCL) vide this Office Order withdraws the Office Order no NHIDCL/Nagaland/D-K/BW/PKG3/2021/1306 dated 10th August 2022 & removes the name of M/s Oasis Projects Limited from the list of "non-performers", and thus enabling M/s Oasis Projects Limited to participate in any bidding process, till the time final decision on debarment is taken by the Ld. Sole Arbitrator.

4. This issues with the approval of Competent Authority.
