NOTICE INVITING TENDER (NIT)

1. NHIDCL has been assigned the work of “Consultancy Services for Preparation of Detailed Project Report for Construction of Major Bridge along with its approaches connecting NH-10 with NH-510 near Singtam, development of its junction and identification & realignment from Km 0+000 to Km 3+074 (Singtam-Tarku) on NH-510 into 2 lane with paved shoulder configuration along with permanent mitigation measures for landslide/sinking/slip zones on existing section in the State of Sikkim” (as per Annexure-I).
2. Proposals are hereby invited from eligible Consultants who meet the guidelines contained in Public Procurement (Preference to Make in India) Order, 2017 (amended on 16.09.2020) for preparation of Detailed Project Report of “Consultancy Services for Preparation of Detailed Project Report for Construction of Major Bridge along with its approaches connecting NH-10 with NH-510 near Singtam, development of its junction and identification & realignment from Km 0+000 to Km 3+074 (Singtam-Tarku) on NH-510 into 2 lane with paved shoulder configuration along with permanent mitigation measures for landslide/sinking/slip zones on existing section in the State of Sikkim”. Consultant submitting Proposal in sole capacity or as a member of joint venture or as an associate shall meet the guidelines contained in Public Procurement (Preference to Make in India) Order, 2017 (amended on 16.09.2020). The Letter of Invitation (LOI) and Terms of Reference (ToR) including Request for Proposal (RFP) is available online on e-tender portal of <https://eprocure.gov.in>. The document can also be downloaded from <Agency Website>. Cost of the Document in the form of a Non-refundable document fee of Rs.5,000 (Rupees Five Thousand only) must be submitted in NHIDCL account online at the time of Submission of Bid proposal, specifying the tender id and bid due date.
2. The RFP has also been uploaded on “INFRACON” (www.infracon.nic.in). As such before submitting the proposal the Consultant shall mandatorily register and enlist themselves (the firm and all key personnel), on the MoRTH portal “INFRACON” and furnish registration details along with its RFP. A copy of Infracon Operation Procedure is also enclosed for bidder’s reference.
3. All the bidders registered on Infracon shall form a Team on Infracon and which would be assigned unique Infracon Team ID. Bidders while submitting the proposal shall quote the Infracon Team ID.
4. Bid must be submitted online at e-tender portal of NHIDCL <https://eprocure.gov.in> on or before bid due date i.e. 04.12.2024 (1500 Hrs.)
