National Highways Infrastructure Development Corporation Limited (the “Authority”) is engaged in the development of National Highways and as part of this endeavour, the Authority has decided to undertake **Construction, Operation and Maintenance of Z-Morh tunnel including approaches on National Highways No.1 (Srinagar Sonamarg Gumri Road) in the UT of J&K on Design, Build, Finance, Operate and Transfer (DBFOT) Annuity basis (Project)**.
