10. To participate in bidding process, bidder have to get (DSC) "Digital Signature Certificate" as per Information Technology Act-2000, to participate in online bidding. This certificate will be required for digitally signing the bid. Bidder can get above mentioned digital certificate from any approved vendors. The Bidder, who already posses valid (DSC)"Digital Signature Certificate" need not to procure new Digital Signature Certificate.
11. The bidders have to submit their bids online in electronic format with Digital Signature. The bid cannot be uploaded without Digital Signature. No proposal will be accepted in physical form. The DSC through which the bid has been uploaded should also be of the Authorized Signatory only failing which the bid shall be rejected.
12. Bids will be opened online as per time schedule mentioned at Sr. No. 5.
13. Before submission of online bids, bidder must ensure that scanned copy of all the necessary documents have been attached with bid.
14. The department will not be responsible for delay in online submission of bids whatsoever reasons may be.
15. All the required information for bid must be filled and submitted online.
16. The bidders are not required to send the physical copies of the documents being uploaded.
