The Bidder, who already posses valid (DSC)"Digital Signature Certificate" need not to procure new Digital Signature Certificate.
12. The bidders have to submit their bids online in electronic format with Digital Signature. The bid cannot be uploaded without Digital Signature. No proposal will be accepted in physical form. The DSC through which the bid has been uploaded should also be of the Authorized Signatory only failing which the bid shall be rejected.

14. Before submission of online bids, bidder must ensure that scanned copy of all the necessary documents have been attached with bid.
15. The department will not be responsible for delay in online submission of bids whatsoever reasons may be.
