This certificate will be required for digitally signing the bid. Bidder can get above mentioned digital certificate from any approved vendors. The Bidder, who already possess valid (DSC) "Digital Signature Certificate" need not to procure new Digital Signature Certificate.
- 9. The bidders have to submit their bids online in electronic format with Digital Signature. The bid cannot be uploaded without Digital Signature.
- 10. Bids will be opened online as per time schedule mentioned at Sr. No. 18.
- 11. Before submission of online bids, bidder must ensure that scanned copy of all the necessary documents have been attached with bid.
- 12. The department will not be responsible for delay in online submission of bids whatsoever reasons may be.
- 13. All the required information for bid must be filled and submitted online.
- 14. Bidders should get ready with the scanned copies of cost of documents & Bid Security as specified in the tender documents.  - (i) All data in respect of Technical / Financial Capacity of the Bidder duly certified by Statutory Auditor should be made available through UDIN verifications and the Statutory Auditor should mention the corresponding UDIN in each of its certificate. This shall be considered in respect of Qualification requirements of Bidder as per RFP clause 4.6.
 - (ii) The bidder has to provide 'Self Certification' that its Bid meets Local Content requirement for 'Class-I Local Supplier' / 'Class-II Local Supplier' as the case may be, mentioning the details of location(s) at which the local value addition is made in both Technical as well as Financial Bid. In case, bidder don't submit the aforesaid certification the bidder will summarily treat as 'Non-Local Supplier'.
 - (iii)Please note that selection of bidder shall be guided by the 'Self Certification' on Local Content in accordance with Cl. 23.7 of RFP.
