National Highways Infrastructure Development Corporation Limited (the "Authority") is engaged in the development of National Highways and as part of this endeavour, the Authority has decided to undertake Construction for 4 - Laning of Silchar (near Budha Nagar) at Existing Km 233+000 (D. Ch.24+560) to Jiribam at Existing km 212+060 (D. Ch. 37+650) of NH-37 (Length: 13.09 km) in the State of Assam and Manipur under NH(O)-NE on Hybrid Annuity Mode (HAM) (Pkg-2). Accordingly, Authority has decided to procure Consultancy Services for appointment of Independent Engineer. Brief particulars of the project are as follows:
