Expression of Interest (EOI) for Empanelment of Bridge Experts in NHIDCL

Subject: -To inspect the failed/completed/on-going structures and checking of bridges/structures proposed in DPR from time to time as and when required for projects in NHIDCL.

1. Introduction

The National Highways & Infrastructure Development Corporation Ltd (NHIDCL) is mandated for the development and maintenance of National Highways, Bridges, Tunnels, and other infrastructure works. To ensure effective monitoring and implementation of bridge works, NHIDCL seeks to empanel qualified Bridge Experts for third-party checks and inspections of various structures.

2. Scope of Work

The empaneled Bridge Experts will be responsible for:

- Inspection of failed, completed, and ongoing structures such as Bridges, VUP, VOP, ROB, RUB, Flyovers etc.
- Study & provide comments on Detailed Project Reports (DPR) of upcoming structures.
- Participate in technical discussions and providing inputs via email or video conferencing as required.

3. Eligibility Criteria

- Educational Qualification:
- (i) Minimum:- Graduate in Civil Engineering or equivalent from a recognized university.
- (ii) Desirable :- Master in structural Engineering
- Age Limit: Maximum age of 70 years. Initial empanelment for 2 years, extendable up to 70 years.
- Disqualification: Persons blacklisted by MoRTH, State PWDs, NHAI,
 NHIDCL, or any other Government organization are disqualified.

Professional Experience:

For Bridge Experts:

- a. At least 20 years of total professional experience, with a minimum of 10 years in design / construction/supervision of major bridges /ROBs / RUBs /Underpasses/Flyovers/ Interchanges.
- b. At least 15 years of total professional experience in design / construction / supervision of major bridges (more than 100m spans) / ROBs / RUBs / Underpasses / Flyovers/ Interchanges.

- c. Modern Bridge Construction Technology: Experience in modern bridge construction technologies such as Pre-Cast Segmental, Balance Cantilever construction, Extradosed bridges, and Cable Stayed bridges etc.
- d. **Additional Qualifications:** Experience in major bridge design/DPR preparation/feasibility study/design review of transportation bridge projects in hilly terrains. Preference may be given to candidates with a Ph.D. or Master's in Structural Engineering/Foundation Engineering/Geotechnical Engineering.

For Retired Government/PSU Engineers: Retired from the post of Superintending Engineer (SE) or equivalent (CGM, ED) and above from MoRTH, CPWD, NHAI, NHIDCL, MES, BRO, State PWD, IRCON, Metro Rail Corporation, IA (Corps of Engineers), etc., with at least 20 years of experience in design / construction / supervision of major bridges (with at least 5 years' experience in more than 100m spans) / ROBs / RUBs / Underpasses / Flyovers/ Interchanges.

6. Terms of Reference (ToR)

Role and Responsibilities

The Bridge Expert shall be part of an expert committee or work on an individual basis to:

- Conduct site inspections of failed, completed, and ongoing structures such as Bridges, VUP, VOP, ROB, RUB, Flyovers, etc., within NHIDCL projects.
- Submit detailed inspection reports within the specified timeline.

- Study and provide comments on the Detailed Project Reports (DPR) of bridges, VUP, VOP, ROB, RUB, Flyovers, etc., within the specified timeline.
- II. Conflict of Interest& System Assessment

The Bridge Expert must ensure there is no conflict of interest with any Contractor, Concessionaire, Authority's Engineer (AE), Independent Engineer (IE), Supervision Consultant (SC), Design Director, Proof Consultant, DPR Consultant or any other entity associated with the project.

The Bridge Expert shall:

- Evaluate the entire system in place by the Contractor, Concessionaire, or Consultant for the construction and maintenance of bridges.
- Review the level of implementation, supervision, and control mechanisms.

III. Reporting & Timelines

The committee or individual Bridge Expert shall adhere to the following reporting and timelines for completion of assignment (T) by NHIDCL:

- **Preliminary Report Submission:** T1 = T + 4, where T is the start date of the assignment at site.
- Final Report Submission: T2 = T1 + 10 days

IV. Compliance & Document Verification

The Bridge Expert shall:

- Ensure compliance with specified requirements as published by IRC, MoRTH, NHAI, BIS, and other relevant standards.
- Include all relevant details and documents in the report.
- Suggest suitable remedial measures and actions to restore failed structures and ensure the continuation of construction and O&M activities.
- Verify adherence to good engineering practices.

V. Implementation Arrangements

The Bridge Expert may:

- Utilize field laboratories established by the Contractor for testing.
- Conduct specific tests in District/Regional/State level laboratories of the employer, NABL accredited labs, or Government engineering colleges.



- Receive full support from NHIDCL for tasks such as sample collection, transportation, and testing.
- Have complete access to project documents, assisted by the concerned GM (P) / DGM (P) of NHIDCL.

VI. Confidentiality

The Bridge Expert shall not disclose any technical information or data relevant to the project to any third party without prior written permission from NHIDCL.
