The Scope of Work constitute slope protection work & restoration of the road includes the routine maintenance of all the assets and facilities existing & constructed within Right of Way (ROW) on the above-mentioned section including maintenance of carriageway, shoulders, drains, road signage etc., and carrying out other works as specified in the bid documents.

- 9. The amount of Bid Security/ Earnest Money is 9.84 Lac. to be submitted in the form of e-Bank Guarantee/Demand Draft/ Bankers Cheque/ FDR only (any other form will not be acceptable) of any scheduled commercial bank approved by RBI having a net worth of not less than Rs.500 crore as per the latest annual report of the bank and must be in the name of the Employer. In case of foreign bank (issued by a branch in India) the net worth in respect of the Indian operations shall only be taken into account. It shall be valid for 45 days beyond the validity of the bid. Any bid having bid security for lesser value and shorter validity period shall be treated as non-responsive. Any Bid not accompanied by Bid Security shall also be treated as NON-RESPONSIVE.
