National Highways Infrastructure Development Corporation Limited (the “Authority”) is engaged in the development of National Highways and as part of this endeavour, the Authority has decided to undertake **Independent Engineer Services for Development, maintenance, management and operation of Greenfield High-Speed Corridor of 166.80 km (NH-6) from Mawlyngkhung (near Shillong) in Meghalaya to Panchgram (near Silchar) in Assam on Hybrid Annuity Mode**”. Accordingly, Authority has decided to procure Consultancy Services for appointment of Independent Engineer. Brief particulars of the project are as follows:
