### Public Notice

1. Whereas, NHIDCL, vide its Public Notice No. NHIDCL/F.No.260733/1366 dated 06.05.2026, published the Provisional List of the Candidates Exempted from Stage-I. Screening Test for E4 to E7 Grades against Recruitment Notice No. 04/2025 dated 09.12.2025 for Direct Recruitment to various Grades E4 to E7 in Technical Cadre.

2. Whereas, with respect to the Provisional Lists of the Candidates Exempted from Stage -I Screening Test for E4 to E7 Grades, following is clarified:

a. Lists of Candidates Exempted, for the posts of Senior Manager (Tech) E-4 Grade, DGM (Tech) E-5 Grade, GM (Tech) E-6 Grade and Sr. GM (Tech) E-7 Grade, are purely based on the data provided by each candidate in his/her application submitted with NHIDCL for the respective posts against Recruitment Notice No. 04/2025 dated 09.12.2025.

b. NHIDCL, further states that at this stage, the data provided by each of the candidate has not been verified and the same shall remain contingent to verification at the time of personal interview of the selected candidates.

c. NHIDCL further states that, the candidates must satisfy themselves about the criteria specified for exemption from Stage-I Eligibility Test as given in Para 7.2 of Recruitment Notice 04/2025 and further that the onus of meeting the criteria of exemption from Stage-I Eligibility Test rests completely with the candidate.

d. NHIDCL further states that, mere inclusion of a candidates' name in the list of Candidates Exempted from Stage -I Eligibility Test does not shift the onus of meeting the criteria for exemption to NHIDCL.

e. The candidates shall produce relevant documents to support his/her claim for such exemption at the time of personal interview/document verification to the satisfaction of the NHIDCL.

f. In case, any candidate's name appears in the list of Candidates Exempted and such candidate does not or may not qualify for the exemption, they are advised to appear for the Stage-I Eligibility Test. Such candidates are also advised to intimate the Concerned Authority at NHIDCL via email at recruitment.nhidcl@nhidcl.com within 07 days of publication of this notice.
