### Public Notice

**Subject: Conduct of Stage-I Eligibility Test and Related Instructions to candidates for Recruitment to Technical Cadre Posts (E-4 to E-7) grade under the Recruitment Notice no. 04/2025; reg,**

1. In reference to the recruitment notification 04/2025 issued for the posts of Senior Manager (Technical) (E-4), Deputy General Manager (Technical) (E-5), General Manager (Technical) (E-6), and Senior General Manager (Technical) (E-7), the following instructions are hereby issued for information of all candidates appearing in Stage-1 Eligibility Test:

a. Examination Pattern

- i. The examination shall consist of 100 multiple-choice objective-type questions and shall be Computer Based Test (Eligibility Test).
- ii. There shall be no negative marking for incorrect answers.
- iii. The question paper shall be bilingual, i.e., in English and Hindi.
- iv. Total duration of the examination shall be 120 minutes.
- v. Additional compensatory time of 20 minutes per hour shall be allowed to PwBD candidates, as applicable.

b. Examination Centres

- i. The Stage-I Eligibility Test for all notified Posts i.e. E-4, E-5, E-6 & E-7 shall be conducted at examination centres located in Delhi & Noida (NCR) on 29.06.2026 (Monday) in a single session from 09.00 AM to 11.00 AM. The test shall be common for all Grades i.e. E-4 to E-7.
- ii. Admit Cards shall be made available on NHIDCL website 03 to 05 days prior to the date of examination.
- iii. The exact address of the examination centre shall be intimated to applicants through the Admit Card.
- iv. Requests for change of examination centre shall not be entertained under any circumstances.

c. Eligible list of candidates for Stage-1 Eligibility Test Exam

All candidates, (except candidates exempted for Stage-1 test) are required to appear in the Stage-1 Eligibility Test. All eligibility criteria for each post as given in the Recruitment Notice No. 04/2025 shall be verified only after Stage 2 test and before conduct of Personal Interview. In case any candidate does not meet the eligibility criteria of qualification and experience, the candidature of such candidates shall be rejected at that stage.

d. General Instructions

i. Candidates are advised to carefully read and strictly adhere to the important instructions contained in the Admit Card.

ii. All correspondence/queries related to Recruitment to E4 to E7 grade shall be made at [direct.recruitment@nhidcl.com](mailto:direct.recruitment@nhidcl.com). No other mode of correspondence shall be valid.

e. Malpractice and disciplinary provisions

Any candidate found indulging in any form of malpractice, misconduct, impersonation, use of unfair means, possession/use of prohibited electronic devices/materials, or violation of examination instructions during the Stage-I Eligibility Test shall be liable for disqualification from the examination and debarment from future recruitments of NHIDCL.

2. Any corrigendum/Addendum relating to the present recruitment process shall be published on NHIDCL website.
