PUBLIC NOTICE

Subject:- Conduct of Stage II Test (Selection Test) and related instructions to candidates for Recruitment to the Posts of Deputy Manager (Finance & Accounts) at E2 grade under the Recruitment Notice No. 02/2026- reg.

1. In reference to the recruitment notification 02/2026 issued for the posts of Dy Manager (Finance and Accounts) at E2 grade under the Recruitment Notice no. 02/2026, the following instructions are hereby issued for information of all candidates appearing in Stage II Test (Selection Test).

a. Examination Pattern:

i. The syllabus for Stage-II (Selection Test) for the posts of Deputy Manager (Finance and Accounts) shall be as per Public Notice No. 263718/311 dated 23.01.2026 available on NHIDCL website.

ii. The Examination shall consist of 100 multiple choice objective type questions and shall be Computer Based Test, as per syllabus available on NHIDCL website.

ii. There shall be negative marking for each incorrect answers.

iii. The question paper shall be bilingual, i.e. in English and Hindi.

iv. Total duration of the examination shall be 120 minutes.

v. Additional compensatory time of 20 minutes per hour shall be allowed to PwBD candidates, as applicable.

b. Examination Centre:

i. The Stage II Selection Test for the Posts of Deputy Manager (Finance & Accounts) E-2 grade shall be conducted at examination centres located in Delhi/ NCR on 08th October, 2026 (Thursday) in one sessions from 10.00 am to 12.00 Noon.

ii. The Examination shall be held, as per schedule given below:

iii. Admit Cards shall be made available for download on NHIDCL website 03 to 05 days prior to the date of examination.

iv. The exact address, & timings of the Examination Centre shall be intimated to the applicants through the Admit Card.

v. No requests for change of examination centre or date shall be entertained under any circumstances.

c. Eligibility of candidates for Stage II (Selection Test) Examination:

i. All candidates who are found eligible in the provisional merit list of Stage I Eligibility Test held on 24.08.2026 (List to be published by NHIDCL) are permitted to appear in the Stage II Selection Test.

ii. The eligibility criteria for the post of Deputy Manager (Finance & Accounts) is as given in the Recruitment Notice No.02/2026. The Candidates are required to satisfy themselves with respect to eligibility conditions.

iii. The NHIDCL shall check and verify documents at the time of Document Verification stage, for which a separate notice will be issued after Stage-2 Selection test. In case any candidate does not have or produce the required documents such as those related to essential qualifications, age and any other criteria prescribed in the recruitment notice, the candidature of such candidate shall be rejected at that stage without any further notice.

d. General Instructions:

i. Candidates are advised to carefully read and strictly adhere to the important instructions mentioned in the Admit Card.

ii. Email ID for complete Recruitment process is direct.recruitment@nhidcl.com. All correspondence/queries related to Recruitment to Deputy Manager (Finance & Accounts) be made at above mentioned email id. No other mode of correspondence shall be valid.

e. Objection Management & email ID

i. The objection management link shall be activated one to two days after the conduct of Stage-II (Selection Test). The objection management link shall remain active for three days.

ii. No objections or examination-related queries pertaining to Stage-II (Selection Test) shall be entertained thereafter.

f. Malpractice and Disciplinary provisions:

Any candidate found indulging in any form of malpractice, misconduct, impersonation, use of unfair means, possession/use of prohibited electronic devices/materials or violation of examination instructions during the Stage-II (Selection Test) Examination shall be liable for disqualification from the Examination and debarment from future recruitment of NHIDCL.

g. TA Claim:

A separate notice for admissibility of TA claim shall be made available on NHIDCL website separately.

2. Any corrigendum/Addendum relating to the present recruitment process shall be published on NHIDCL website.
