DEBARMENT NOTICE

Sub: Debarment of Sh. Vema Reddy from engagement on NHIDCL/MoRT&H projects for a period of 01 (One) years.

It is brought to notice of all the Divisions/Units of NHIDCL and other agencies of MoRT&H that Sh. Vema Reddy was appointed as "Resident Cum Highway Engineer" by M/s Shrikhande Consultant Pvt. Ltd. In association with Infra Design Studio Pvt. Ltd. for the work of "*Consultancy Services as Authority's Engineer for supervision of :- (i) Construction & Upgradation to 2 lane with paved shoulder from Design Km. 67.805 (at the end of Km 83rd tunnel near Dhrabshala) to Km 80.675 (Dulhasti) of 12.87 Km length on Khellani - Kishtwar - Chattroo section of NH-244 in the Union Territory of Jammu & Kashmir on EPC mode (Pkg-III). (ii) Construction of Kishtwar Bypass with 2 lane with paved shoulder from Design Km 80.675 (Dulhasti) to Km 95.550 (Bandarkoot) of 14.88 Km length Khellani - Kishtwar - Chattroo section and a link road to Kishtwar town of 1.871 km on NH-244 in the Union Territory of Jammu & Kashmir on EPC mode (Pkg-IV). (iii) Construction/Upgradation of 2 lane with paved shoulder from Design Km 95.55 (Bandarkoot) to Km 111.06 (Chattroo) of 15.52 Km length on Khellani-Kishtwar-Chattroo section on NH-244 in the Union Territory of J&K on EPC mode (Pkg-V)*".

2. Sh. Vema Reddy had left the assignment without approval of the Employer, i.e. NHIDCL. He was served a Show Cause Notice by NHIDCL RO-Jammu on 15.09.2023 asking him to furnish reply within 15 days, however, no reply was received within the stipulated period.



Clause 4.5.6 of GCC of Contract Agreement reads that, "*If any member of the approved team of a consultant engaged by NHIDCL leaves that consultant before completion of the jobs; shall be barred for a period of 06 months to 24 months from being engaged as a team member of any other consultant working (or to be appointed) for any other NHIDCL/MoRT&H project*".

4. Therefore, as per stipulation of the GCC Clause 4.5.6 of the Contract Agreement, Sh. Vema Reddy is hereby debarred for a period of 01 (One) year from
