NOTICE FOR CANCELLATION OF DEBARMENT

It is brought to notice of all the divisions/units of NHIDCL and other agencies of MoRT&H that Mr. Ashok Kumar Adarsha was appointed as "Resident Engineer-I" by M/s. CMEC Consulting Engineers Private Ltd in JV with AICONS in association with KPS Engineers Pvt. Ltd. for the work of "Consultancy services as Authority's Engineer for Supervision of "Upgradation to 2 lane with paved shoulders of Dulte - Champhai road (International Corridor) of NH-6 from Design Chainage Km 54.400 to km 111.580 (Package-I, II & III) in the State of Mizoram under Bharatmala Pariyojna on EPC mode".


2. Mr. Ashok Kumar Adarsha was debarred by NHIDCL vide Debarment Notice No. NHIDCL/Mizoram/NH-6/IC/AE/2021-22/100 dated 14.06.2022 for a period of 2 years. Thereafter, Mr. Ashok Kumar Adarsha has submitted his representation vide letter dated 29.06.2022, 20.06.2022 and email dated 17.06.2022 which has been examined by NHIDCL.

3. Since Mr. Ashok Kumar Adarsha was selected one of the project of the NHAI i.e. "Redesigning, Rehabilitation and Upgradation to Four Lane configuration & Strengthening of Rohna/ Hassangarh to Jhajjar section from Km 44.80 to Km 80.250 (Design Chainage) (Length 35.450Km) of NH-334 B in the State of Haryana on Hybrid Annuity Mode" on 17.06.2021, which is before the award the NHIDCL work on 06.07.2021. Therefore, Competent Authority has approved the cancellation of the Debarment Notice of Mr. Ashok Kumar Adarsha.
