WHEREAS, Bid for the work of "Construction of Two laning with Hard shoulder road of 1. Ram-Mandir to Arrowa section of NH-113 from Design Km 0.000 to Km 2.910 (Existing Km 65.080 to Km 68.550) of total length 2.755 km excluding Tidding Bridge (154.725 m) in the State of Arunachal Pradesh on EPC mode" (hereinafter referred as "Project") was invited by National Highways & Infrastructure Development Corporation Limited (NHIDCL) (hereinafter referred as the "Authority") with bid due date 13.10.2021; and.

2. WHEREAS, M/s Dagmo Riba had submitted bid for subject work online on 13.10.2021. Bid submitted by M/s Dagmo Riba was evaluated on the basis of the documents submitted alongwith the bid. Consequent to the evaluation of the bid by the Technical Evaluation Committee (TEC), the Financial Bid of the M/s Dagmo Riba was opened on 14.10.2021 on CPPP Portal; and,

3. WHEREAS, a complaint was received by NHIDCL, informing that M/s Dagmo Riba has submitted false work experience certificate and other documents in the bid for the subject work. The

experience certificates submitted by M/s Dagmo Riba have been verified from the certificates issuing Authority.

4. WHEREAS, in response to NHIDCL's letter seeking verification of the work experience, Project Manager, Project Implementation Unit, Infrastructure Development Investment Program for Tourism, Govt. of Uttarakhand, Dehradun, vide letter No. 10584/2-10-ADB/IDIPT/2020-21 dated 17.11.2021 informed the NHIDCL that:

"In reference to the said letters, it's for your kind information that the attached completion certificate hasn't been issued to the contractor M/s Dagmo Riba for the sub project "Development of North Entry in Corbett at Kotdwar" and can't be treated as the completion certificate.

Hence, the completion certificate with amount costing INR 5,24,05,482.00 has been attached for your kind knowledge.

5. WHEREAS, consequent upon receipt of the letter dated 17.11.2021, the bid of M/s Dagmo Riba was considered as non-responsive.

WHEREAS, M/s Dagmo Riba, with malafide intention has caused breach to the relevant 6. provisions of the RFP.

7. WHEREAS, NHIDCL vide letter at ref. (ii) above, issued the Show Cause Notice for debarment to M/s Dagmo Riba and requested to explain in writing within a period of 15 days, that as to why M/s Dagmo Riba, should not be debarred from participating in the future projects of NHIDCL. It was also informed that in case M/s Dagmo Riba, fails to submit its reply within the stipulated period, it shall be presumed that M/s Dagmo Riba, has nothing to explain and further action will be taken in accordance with the provisions of the RFP.

8. WHEREAS, M/s Dagmo Riba vide letter at Re.(iii) above, submitted the reply to the Show Cause Notice for Debarment. Vide the reply, M/s Dagmo Riba has requested not to initiate any action against M/s Dagmo Riba as the said firm has been declared Technically Non-Responsive at the initial stage and is not challenging or pressing against the legality & validity of such rejection/result declaration. M/s Dagmo Riba has further stated that the provision of the clause 2.6.3 doesn't apply to the bidders whose firm has been declared Technically Non-Responsive forthwith as they are no longer in the bidding race.

9. WHEREAS, the reply dated 04.02.2022 received from M/s Dagmo Riba, has been perused, examined and is rejected on the ground of the following reasons:-

a) In the reply submitted by M/s Dagmo Riba, M/s Dagmo Riba has not mentioned about the false work experience certificate submitted by them, which means that they have nothing to say in this regard and M/s Dagmo Riba with malafide intention has caused breach to the relevant provisions of the RFP.

b) Statement of M/s Dagmo Riba that "the provision of the clause 2.6.3 doesn't apply to the bidders whose firm has been declared Technically Non-Responsive forthwith as they are no longer in the bidding race" may not be accepted as NHIDCL has declared M/s Dagmo Riba as technically non-responsive after proper evaluation of the bid submitted by M/s Dagmo Riba and thereafter experience certificates submitted by the M/s Dagmo Riba has been got verified from the concern authority which delayed the bidding process.

10. **WHEREAS**, the reply given by M/s Dagmo Riba is not justified and the act of M/s Dagmo Riba, has caused the loss of time and efforts of the Authority as well as delayed the project in question and M/s Dagmo Riba, has also engaged itself in fraudulent practice during the Bidding Process.

11. All the earlier correspondences/letters/notices of the Authority/NHIDCL, may be read as part & parcel of this order.

12. In view of the aforesaid facts and circumstances, M/s Dagmo Riba, is hereby debarred for a period of two years from participating in the future projects of NHIDCL.

13. This order of debarment is herby issued without prejudice to the rights of the NHIDCL available under the relevant provisions of the RFP as well as applicable laws.

14. This issues with the approval of the Competent Authority.
