Whereas, Shri Mohammad Monish, had joined the assignment Resident cum Highway Engineer-II on 26.05.2022 as proposed by the Consultant, M/s Planing & Infrastructure Development Consultants Pvt Ltd. for the "CONSULTANCY SEVICES FOR AUTHORITY'S ENGINEER FOR SUPERVISION OF (i) Construction of two lane with paved shoulders road from Tamenglong to Mahur (NH-137) in the state of Manipur starting from km 54.180 near Azuram to km 80.630 near Mandeu (Package-5) on EPC mode. (ii) Construction of two lane with paved shoulders road from Tamenglong to Mahur (NH-137)

3. Whereas, Shri Mohammad Monish, left the site without any prior permission and approval of the Authority or the Authority's Engineer (Consultant).

4. Whereas, Shri Mohammad Monish was served a Show Cause notice by NHIDCL, PMU-Tamenglong under RO-Imphal vide letter no. NHIDCL/PMU-TAMENGLONG/T-M/AE/PKG(5&6)/2023-24/1457 dated 23.02.2024 wherein the Authority sought explanation from him that why did he leave the site without permission along with why action for debarment for a period of 24 months i.e. 2 years from participating in any future projects of NHIDCL/MoRTH as per Clause No. 4.5.2 & 4.5.6 may not be taken against him.

5. Whereas, PMU-Tamenglong vide letter no. NHIDCL/PMU-TAMENGLONG/T-M/AE/PKG(5&6)/2023-24/1453 dated 13.03.2024 and RO-Imphal NHIDCL vide letter no. NHIDCL/RO-Imphal/NH-137/T-M(PKG-5&6)/AE-PIDCPL/KEYPERSONNEL/1385 dated 13.03.2024 informed that Sh. Mohammad Monish has not submitted any reply of Show Cause Notice.

6. Whereas, Clause 4.5.6 of the Contract Agreement reads that, "If any member of the approved team of a consultant engaged by NHIDCL leaves that consultant before completion of the jobs; he shall be barred for a period of 6 months to 24 months from being engaged as a team leader of any other consultant working (or to be appointed) for any other NHIDCL/MORTH projects."

7. Whereas, Shri Mohammad Monish was on unauthorized leave without informing the Authority during subsistence of the project work, therefore he was in breach of GCC Clause 4.5.6 of the Contract Agreement. Accordingly, Shri Mohammad Monish is hereby debarred for a period of 24 (Twenty-Four) Months from engagement in NHIDCL/MoRT&H's projects of/or to be undertaken by it either directly or indirectly effective from the date of this circular.
