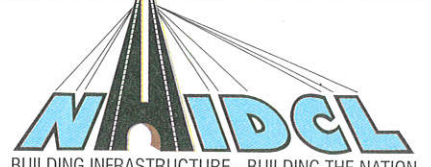

Package 6, 7 & 8) on Aizawl-Tuipang section of NH54 in the state of Mizoram on EPC mode with JICA loan assistance".
