It is brought to notice of all the Divisions/Units of NHIDCL and other agencies of MoRT&H that Sh. Tikendrajit Das was appointed as "Tunnel Safety Expert" by M/s Global Infra Solutions in association with Infycons Creative Software Pvt Ltd for the work of "Consultancy services as authority's engineer for supervision of (i) Upgradation to Two-lane with paved shoulder from Km 12+850 to Km 20+300 of 7.450 Km length on Goha-Khellani section and link road to Goha Village of 2.016 Km on NH-244 in UT of Jammu & Kashmir on EPC mode,(ii) Upgradation to Two-lane with paved shoulder from Km 20+300 to Km 29+030 of 8.730 Km length on Goha-Khellani section on NH-244 in UT of Jammu & Kashmir on EPC mode,(iii) Construction of Bi-directional tunnel at Km 83rd of length 495m including approach road of 664m and a Major Bridge of 110m from Km 82+675 to Km 82+925 on NH-244 in UT of Jammu & Kashmir on EPC mode".

2. Sh. Tikendrajit Das had left the assignment without approval of the Employer, i.e., NHIDCL. He was served a Show Cause Notice by NHIDCL HQ on 14.07.2023 and no response was received within the given time even after reminders.

Clause 4.5.6 of the Contract Agreement reads that, "If any member of the approved team of a consultant engaged by NHIDCL leaves that consultant before completion of the jobs; he shall be barred for a period of 6 months to 24 months from being engaged as a team leader of any other consultant working (or to be appointed) for any other NHIDCL/MoRT&H project."

4. Therefore, as per stipulations of the GCC Clause 4.5.6 of the Contract Agreement, Sh. Tikendrajit Das is hereby debarred for a period of 2 (two) years from engagement in NHIDCL/MORT&H projects of/or to be undertaken by it either directly or indirectly effective from the date of issue of this notice.
