Subject: Debarment of Mr. Bageshwar Kumar from engagement on NHIDCL/MoRTH projects for 2 years (24 months).

It is brought to notice of all the Division/Units of NHIDCL and other agencies of MoRTH that Mr. Bageshwar Kumar was appointed as “**Resident cum Highway Engineer**” by M/s Technocrats Advisory Services Private Limited in Association with M/s Jagadambika Infra Solution Pvt Ltd. for the work of Consultancy Service of Authority’s Engineers for supervision of “Construction of (i) 2 lane with hard shoulders of Changtongya- Longleng road on EPC basis from existing Km 0.000 to Km 16.592 (Design Chainage Km 0.000 to Km 18.779) (Design Length – 18.779 Km) (Pkg – I) (ii) 2 Lane with hard shoulders of Changtongya – Longleng road on EPC basis from existing Km 16.530 to Km 29.530 (Design Chainage Km 18.779 to Km 33.428) (Design Length – 14.649 Km) (Pkg-2) in the State of Nagaland under NH (O) Plan under SARDP – NE.

2. Mr. Bageshwar Kumar has been on unauthorized leave from 25.09.2023 till date showing unprofessional and lackadaisical approach towards his obligations, thereby violating the GCC clause 4.5.6 of the Contract Agreement.

3. Therefore, as per stipulation of the GCC clause 4.5.6 of the Contract Agreement, Mr. Bageshwar Kumar is hereby debarred for 2 years (24 month) from engagement on NHIDCL/MoRTH project of/or to be undertaken by it either directly or indirectly effective from the date of this circular.
