CIRCULAR

Subject: Debarment of Sh Saka Sreenivasu from engagement on NHIDCL's projects for 12 months.

It is brought to notice of all the Divisions/Units of NHIDCL that Sh Saka Sreenivasu was appointed as Team Leader Cum Senior Highway Engineer by *M/s Centro De Estudios De Materiales Y Control De Obra S.A.*, for the work of Consultancy Services for Authority's Engineer for supervision of "Construction of two lane of Peren-Dimapur section NH-129A from Design Km 109.494 to Km 126.775(Length- 17.281Km) (Pkg-I) & Design Km 126.775 to Km 146.450(Length-19.675 Km) (Pkg-II) under NH(O)-TSP in the State of Nagaland on EPC mode".

2. Sh. Saka Sreenivasu has joined some other project without the knowledge of the Competent Authority, after signing the undertaking for the subject project which is against the Contract Agreement.

3. Therefore, as per stipulations of the GCC clause 4.5.6 of the Contract Agreement, and the undertaking appended therewith, Sh. Saka Sreenivasu is hereby debarred for one year(12 months) from engagement on NHIDCL's project of/or to be undertaken by it either directly or indirectly effective from the issuing date of this circular.
