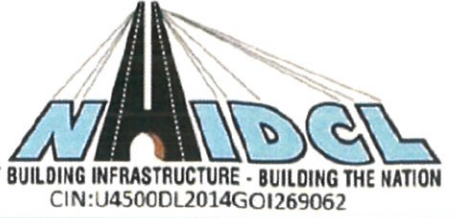

CIRCULAR

Sub.: Debarment of Sh. Jagdish Singh from engagement on NHIDCL Projects for a period of two years.

It is brought to the notice of all the Divisions/Units of NHIDCL and other agencies of MoRT&H that Sh. Jagdish Singh was appointed as Resident Engineer by M/s Yongma Engineering Co Ltd in JV with Redecon (India) Pvt Ltd and in Association with CHO & Kim Engineering Pvt Ltd for the work of Consultancy Services for Authority's Engineer for the (i) Construction of alternative highway (Package-IVA) from 0.00 to 13.00 of Bagrakot-Kafer section of NH-717A on EPC mode in state of West Bengal (ii) Construction of alternative highway (Package-IVB) from 13.00 to 25.60 of Bagrakot-Kafer section of NH-717A on EPC mode in state of West Bengal (iii) Construction of alternative highway (Package-IVD) from 26.10 to 40.00 of Bagrakot-Kafer section of NH-717A on EPC mode in state of West Bengal (iv) Construction of alternative highway (Package-IVC) from 25.60 to 26.10 of Bagrakot-Kafer section of NH-717A on EPC mode in state of West Bengal (v) Construction of Mechi Bridge and Approaches on India-Nepal border linking Kakarvitta in Nepal and Panitanki in India under Engineering Procurement and Construction (EPC) Mode.

2. Sh. Jagdish Singh had left the assignment without the approval of the Employer, i.e. NHIDCL. He was served a show cause notice by NHIDCL, RO-Gangtok on 26.06.2020 and his reply thereof was received on 09.07.2020. However, the reply furnished by him is not found satisfactory.

3. Therefore, as per stipulations in Clause 11.2 of the TOR of the Contract Agreement, Sh. Jagdish Singh is hereby debarred for a period of two years for engagement on NHIDCL's projects of/or to be undertaken by it either directly/indirectly effective from the date of this circular.
