### DEBARMENT NOTICE

**Sub: Debarment of Shri Amarendra Kumar Singh from engagement in NHIDCL/MORTH Projects for a period of 24 (Twenty four) Months.**

It is brought to the notice of all the Divisions/Units of NHIDCL and other agencies of MORT&H that Shri Amarendra Kumar Singh was appointed as Resident Engineer cum Highway Engineer by M/s ALTINOK Consulting Engineering Inc In JV with M/s EDMAC Engineering Consultant (I) Pvt. Ltd. and In Association with M/s DSD Infratech Management Pvt. Ltd for the work of "Consultancy services for Authority's Engineer for supervision of construction & upgradation of existing road on NH-510 between Rabangla to Gyalshing to 2-lane with paved shoulder configuration in the state of Sikkim under SARDP-NE Phase 'A' on EPC mode for (i) km 32+500 to km 33+600 (Package-III), (ii) km 33+600 to km 58+840 (Package-IV), (iii) km 58+840 to km 75+000 (Package-V) & (iv) km 75+000 to km 90+210 (Package-VI)."

2. Shri Amarendra Kumar Singh had not joined the assignment and the Authority's Engineer M/s ALTINOK Consulting Engineering Inc In JV with M/s EDMAC Engineering Consultant (I) Pvt. Ltd. and In Association with M/s DSD Infratech Management Pvt. Ltd has sought his replacement vide letter no. 107 dated 17.03.2023 citing the reason that Mr. Amender Kumar Singh has found another job and will not be available for the project NH-510 without approval of the Authority, i.e. NHIDCL. He was served a Show Cause notice by NHIDCL, PMU-Gyalshing under RO-Gangtok on 03.07.2023, and his reply thereof was received on 07.07.2023, which was found unsatisfactory.

3. Clause 4.5.6 of the Contract Agreement reads that, ***"If any member of the approved team of a consultant engaged by NHIDCL leaves that consultant before completion of the jobs; he shall be barred for a period of 6 months to 24 months from being engaged as a team leader of any other consultant working (or to be appointed) for any other NHIDCL/MORTH projects."***

4. Therefore, as per stipulations of the GCC Clause 4.5.6 of the Contract Agreement, Shri Amarendra Kumar Singh is hereby debarred for a period of 24
