DEBARMENT NOTICE

Sub: Debarment of Shri Tushar Kanti Chakraborty from engagement in NHIDCL/MoRTH Projects for a period of 02 (Two) years.

It is brought to the notice of all the Divisions/Units of NHIDCL and other agencies of MoRTH that Shri Tushar Kanti Chakraborty was appointed as Resident Engineer cum Highway Engineer by M/s AECOM Asia Company Ltd in Association with Krivam Consultant Pvt. Ltd for the work of "Consultancy Services for Authority's Engineer for Supervision of the following Projects viz. Construction and Upgradation of existing road to 2-Lane with paved shoulder configuration of Rhenock-Menla Spur (NH-717B) on EPC Mode under SARDP-NE Phase 'A' in the state of Sikkim between: (i) Km 20.340 to Km 27.200 (Package-IIA) [Rongli Bridge-Rongli Bypass End stretch], (ii) Km 27.200 to Km 37.600 (Package-IIB) [Rongli Bypass End-Rolep Bridge Stretch], (iii) Km 37.600 to Km 52.000 (Package-IIC) [New Rolep Bridge-Chochenpheri stretch], (iv) Km 52.000 to Km 82.000 (Package-IIIA) [Chochenpheri-Helipad stretch], & (v) Km 82.000 to Km 94.030 (Package-IIIB) [Helipad-Menla stretch] in the state of Sikkim, India under Engineering Procurement and Construction (EPC) Mode."

2. Shri Tushar Kanti Chakraborty had left the assignment without approval of the Employer, i.e. NHIDCL. He was served a Show Cause notice by NHIDCL, PMU-Rhenock under RO-Gangtok on 29.04.2023, and his reply thereof was received on 03.05.2023, which was found unsatisfactory.

3. Clause 4.5.6 of the Contract Agreement reads that, *"If any member of the approved team of a consultant engaged by NHIDCL leaves that consultant before completion of the jobs; he shall be barred for a period of 6 months to 24 months from being engaged as a team leader of any other consultant working (or to be appointed) for any other NHIDCL/MoRTH projects."*

4. Therefore, as per stipulations of the GCC Clause 4.5.6 of the Contract Agreement, Shri Tushar Kanti Chakraborty is hereby debarred for a period of 02 (Two) years from engagement in NHIDCL/MoRTH's projects of/or to be undertaken by it either directly or indirectly effective from the date of this circular.
