### DEBARMENT NOTICE

Subject: Debarment of Mr. Sheo Shanker Dubey from engagement on NHIDCL/MoRT&H projects for a period of 24 under Clause 9 (Fake CV) of General Condition of Contract.

It is hereby intimated to all the divisions/units of NHIDCL and other agencies of MoRT&H that Mr. Sheo Shanker Dubey was appointed as "Team leader cum senior highway Engineer" by the consultancy firm M/s Indian Technocrat Ltd. In JV with MSPARK Futuristics & in association with imaGIS Engineering Solutions Pvt. Ltd. for the work:

"Consultancy Service for Authority's Engineer for Supervision of Widening/Improvement to 4 (Four) Lane with Paved Shoulder from Ch. 99+930km to Ch.143+680 km (Design Ch.96+000km to Ch.139+750km) for Package-8 of Bilasipura- Guwahati Road (NH 17) (Section: Paikan to Dhupdhara Sahar) in the state of Assam on EPC mode".

2. RO-Guwahati informed that Mr. Sheo Shanker Dubey, Team Leader cum senior Highway Engineer had claimed experience certificates with regard to his employment with M/s Atlanta Limited from 2012 to 2015. The Experience certificates submitted by Mr. Sheo Shanker Dubey were forwarded for verification to M/s Atlanta Limited, who, vide e-mail dated 12.11.2024 informed that, the certificate furnished by the said personnel was fake , as, no such letter was issued by M/s Atlanta Limited at any point of time.

3. Further, PMU Bongaigaon issued a Show Cause Notice to Mr. Sheo Shanker Dubey as per applicable clause 9 of GCC. The reply submitted by Mr. Sheo Shanaker Dubey was not found satisfactory.

4. Also, upon unsatisfactory reply received from Mr. Sheo Shanker Dubey on final opportunity given, the authority i.e. NHIDCL hereby debars, Mr. Sheo Shanker Dubey, from participating in future projects of NHIDCL/MoRT&H/NHAI/BRO for a period of 24 months from the date of issue of this debarment as per Clause 9 of Special Condition of Contract Agreement.

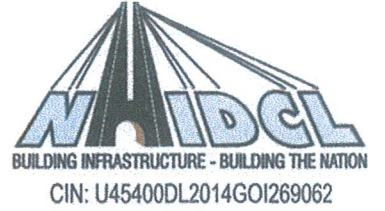
