

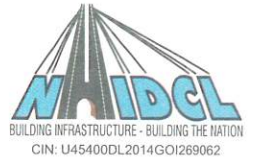

DEBARMENT ORDER

Subject: Debarment of Mr. Umesh Sharma from engagement on NHIDCL/MORT&H projects for 24 months.

It is brought to notice of all the Divisions/Units of NHIDCL and other agencies of MoRT&H that Mr. Umesh Sharma was appointed as “**Bridge/Structural Engineer**” by M/s CEMOSA JV M/s Pioneer Infra Consultants Pvt. Ltd. in Association with Introsolt Solutions for the work of “Consultancy services for Authority’s Engineer for Supervision of (i)“Construction of 2 Laning with hard shoulders of Peren -Dimapur Section of NH 129A from design Km 109.494 to Km 126.775 (length of 17.281 Km) in the state of Nagaland on EPC mode (Package-I) under NH (O) TSP (ii) “Construction of 2 Laning with hard shoulders of Peren - Dimapur Section of NH 129A from design Km 126.775 to Km 146.450 (length of 19.675 Km) in the state of Nagaland on EPC mode (Package-II) under NH (O) TSP.”

2. Mr. Umesh Sharma had been on unauthorized leave from 09.02.2024 till date showing unprofessional and lackadaisical approach towards his obligations, thereby violating the GCC Clause 4.5.6 of the Consultancy Agreement.

3. Therefore, as per stipulations of the GCC Clause 4.5.6 of the Consultancy Agreement Mr. Umesh Sharma is hereby debarred for 24 months from engagement on NHIDCL/MORT&H’s project of/or to be undertaken by it either directly or indirectly effective from the date of this circular.
