## DEBARMENT ORDER

**Subject: Debarment of Mr. Deepak Sharma from engagement in NHIDCL/MORT&H projects for 06 months.**

It is brought to notice of all the Divisions/Units of NHIDCL and other agencies of MoRT&H that **Mr. Deepak Sharma** was appointed as “Senior Pavement Specialist” by M/s CEMOSA JV M/s Pioneer Infra Consultants Pvt. Ltd. in Association with M/s Nexgen Infra Solution for the work of Consultancy services for Authority’s Engineer for (i) Construction of two lane with paved shoulder of Kohima-Bypass Road connecting NH-39 (New NH-02), NH-150(New NH-02), NH-61(New NH-29) and NH-39 (New NH-02) from Design Km 32.000 to design Km 43.454 [Design Length – 11.454 Km] in the state of Nagaland Under SARDP-NE on EPC Mode (Package IV) (ii) Upgradation of existing road to 2-Lane with Paved Shoulder from Kohima to Mao from Km 185.540 to Km 211.709 (Design length – 26.249) of NH -39 (New NH – 02) under NH(O) – TSP in the state of Nagaland in EPC mode.


2. Mr. Deepak Sharma has left the project midway as the AE has also intimated vide email dated 06.02.2024 that, Mr. Deepak Sharma is not interested to continue with the project. He has provided his consent for his availability for the entire duration of the subject project, but he has not completed the assignment, thereby violating CA, TOR, Section-6, Cl. 11.2.

3. Therefore, as per stipulations of the CA, TOR, Section-6, Cl. 1 1.2, Mr. Deepak Sharma is hereby debarred for 06 months from engagement on NHIDCL/MORT&H’s project of/or to be undertaken by it either directly or indirectly effective from the date of this circular.
