## Subject: - Debarment/Blacklisting of Dr. S.K. Dubey (DOB: 15.03.1969) from engagement on NHIDCL/MORT&H projects for two years-reg.

It is brought to notice of all the Divisions/Units of NHIDCL and other agencies of MORT&H that Dr. S.K. Dubey (DOB: 15.03.1969) was proposed as Team Leader cum Sr. Highway Engineer by the consultancy firm M/s M/s Geo Designs & Research (P) Ltd. for the work of "Consultancy services for Authority's Engineer for Supervision of:

- (i) Improvement of existing road to 2 laning with Hard Shoulders of Maram- Peren section (Package-IA, length- 22.340 Km) from Design Chainage 0.000 km to 22.340 Km on NH-129A in the State of Manipur on EPC Mode.
- (ii) Improvement of existing road to 2 laning with Hard Shoulders of Maram- Peren section (Package-IB, length- 17.660 Km) from Design Chainage 22.340 Km to Km 40.000 on NH-129A in the State of Manipur on EPC mode.
- (iii) Improvement of existing road to 2 laning with Hard Shoulders of 2 laning of Maram-Peren section (Package-IIA, length- 16.840 Km) from Design Chainage 40.000 km to 56.840 Km on NH-129A in the State of Manipur on EPC mode.
- (iv) Improvement of existing road to 2 laning with Hard Shoulders of 2 laning of Maram- Peren section (Package-IIB, length- 18.160 Km) from Design Chainage 56.840 km to km 75.000 on NH-129A in the State of Manipur on EPC mode".

2. Dr. S.K. Dubey submitted fake and fabricated master's degree along with the CV. Therefore, as per the provisions of Contract Agreement and MoRT&H circular no. RW/NH-33044/24/2020-S&R(P&B) dated 06.01.2021, Dr. S.K. Dubey is hereby debarred/blacklisted from participating in future MoRTH or its Executing Agencies projects for a period of 2 years from the date of issue of this circular.
