## DEBARMENT NOTICE

**Subject:** Debarment of Sh. Vikas Kumar Singh from engagement in NHIDCL/MoRTH Projects for a period of 02 years.

It is hereby intimated to all the divisions/units of NHIDCL and other agencies of MoRTH that Sh. Vikas Kumar Singh was selected as the 'Senior Quality Cum Material Engineer' by M/s Bloom Companies LLC in Association with Shree Bhawani Consultancy Services Pvt. Ltd for the work of Consultancy services for Authority's Engineer for Supervision of: (i) Widening to 2 (Two) Lane with Paved shoulder of Imphal to Jiribam section of NH-37 from Design chainage 3.275 km to 15.940 km (Total length= 12.665 Km)(PKG-1)in the State of Manipur on Engineering, Procurement & Construction (EPC). (ii) Widening to 2 (Two) Lane with Paved shoulder of Imphal to Jiribam section of NH-37 from Design chainage 15.940 km to 33.120 km (Total length= 17.180 Km) (PKG-2) in the State of Manipur on Engineering, Procurement & Construction (EPC). (iii) Widening to 2 (Two) Lane with Paved shoulder of Imphal to Jiribam section of NH-37 from Design chainage 33.000 km to 66.390 km (existing chainage from km 33.395 to km 67.496) (PKG-3) in the State of Manipur on Engineering, Procurement & Construction (EPC) mode. (iv) Construction of 4-Lane Bridge over Irang river on Imphal- Jiribam road section (95.5000 km) NH-37 (Old NH- 53) in the state of Manipur on Engineering, Procurement and Consultancy (EPC) mode.


2. The RO-Imphal has informed that Sh. Vikas Kumar Singh is not available to render their services for the subject project even after giving his consent for his availability for entire duration of the project.

3. Therefore, as per stipulation of the GCC Clause 4.5.6 of Contract Agreement, Sh. Vikas Kumar Singh is hereby debarred/blacklisted from participating in future projects of NHIDCL/MoRTH excluding agencies for a period of 02 years from the date of issue of this notice.
