DEBARMENT ORDER

Sub: Debarment of Sh. Arun Kumar from engagement on NHIDCL/MoRT&H projects for a period of 01 (One) year.

It is brought to notice of all the Divisions/Units of NHIDCL and other agencies of MoRT&H that Sh. Ashok Kumar Sharma was appointed as "Bridge/Structure Engineer" by M/s Segmental Consulting & Infrastructure Advisory Pvt. Ltd. (JV) SA Infrastructure Consultant Pvt. Ltd. for the work of "Consultancy Services as Authority's Engineer for Supervision of :- (i) Construction of Uni-Directional Khellani Tunnel of length 1.574 Km & its approach Road from Km. 29.030 to Km. 31.449 of total length of 2.419 Km on NH-244 in UT of J&K (G-K- Pkg-III), (ii) Construction & Upgradation to 2 lane with paved shoulder from Design Km. 31.449 (Khellani) (Ex. Km 44.946) to Km. 51.700 (Prem Nagar) (Ex. Km. 68+617) of 20.251 Km length on Khellani-Kishtwar-Chattroo section of NH-244 in UT of J&K (Pkg-I) & (iii) Construction & Upgradation to 2 lane with paved shoulder from Design Km. 51.700 (Prem Nagar) to Km 66.535 (New Thathri) of 14.84 Km length on Khellani-Kishtwar-Chattroo section of NH-244 in the UT of J&K (Pkg-II)".


2. Sh. Arun Kumar left the assignment without prior approval of the Employer, i.e., NHIDCL. He was served a Show Cause Notice by NHIDCL RO-Jammu vide letter no. 917 dated 26.10.2024 asking him to furnish reply within 15 days. However, no reply was received from his end within the stipulated time.

3. Clause 4.5.6 of GCC of Contract Agreement reads that, "If any member of the approved team of a consultant engaged by NHIDCL leaves that consultant before completion of the jobs; shall be barred for a period of 06 months to 24 months from being engaged as a team member of any other consultant working (or to be appointed) for any other NHIDCL/MoRT&H project".

4. Therefore, as per the GCC Clause 4.5.6, Sh. Arun Kumar is hereby debarred for a period of 01 (One) year from engagement in NHIDCL/MoRT&H projects or to be undertaken by it either directly or indirectly effective from the date of issue of this order.
