WHEREAS, Letter of Acceptance (LOA) for the work "Barbed wire fencing work along the perimeter (80m x 100m) of NHIDCL-Site Office Sarchu, UT of Ladakh along with installation of 14 ft. wide steel gate, (hereinafter referred as "Project") was issued to M/s JMM Infracon (hereinafter referred as the "Selected Bidder") vide ref (i) by National Highways Infrastructure & Development Corporation Limited (NHIDCL)- RO-Ladakh (hereinafter referred as the "Authority"); and.

(iii) to which Selected Bidder expressed their denial in continuing with the work vide email mentioned at ref (iv).

4. WHEREAS, Given the extremely tough climatic conditions and limited working window at Sarchu, there are irreparable losses incurred upon RO Ladakh, NHIDCL due to negligence caused by Selected Bidder.

5. Hence, M/s JMM Infracon is hereby debarred for a period of 01 (one) year effective from the date of issue of this order, from participating in the future projects of NHIDCL, directly or indirectly, in any form, in any work connected with NHIDCL.

6. This letter is issued without prejudice to any other right or remedy available to the Authority under the NIQ document and/or applicable law.
