It is hereby intimated to all the divisions/units of NHIDCL and other agencies of MoRTH that **Mr. Kamlesh Prasad Shah** was selected as the 'Senior Bridge/Structural Engineer' by M/s K and J Projects Pvt. Ltd. in association with M/s MPG Engineering Consultancy Pvt. Ltd for the work of Consultancy Services For Authority's Engineer For Supervision of Improvement of existing road to 2 laning with Hard Shoulders of Maram-Peren section (Package-III, length 34.494 km) from Design Chainage km 75+000 to km 109+494 on NH-129A in the State of Manipur on EPC Mode.

2. Authority's Engineer vide their letter no. Nil dated 23.12.2022 has informed that **Mr. Kamlesh Prasad Shah** has denied joining the project site and not available to render their services for the subject project.

3. Therefore, as per stipulation of the GCC Clause 4.5.6 of Contract Agreement, **Mr. Kamlesh Prasad Shah** is hereby debarred/blacklisted from participating in future projects of NHIDCL/MoRTH excluding agencies for a period of 02 years from the date of issue of this notice.
