## **DEBARMENT NOTICE**

**Sub:-** Debarment of Sh. Krishana Kumar Chaturvedi from engagement of NHIDCI/ MoRT&H project for a period of**12** months.

It is brought to the notice of all the Divisions/ Units of NHIDCL and other agencies of MoRT&H that Sh. Krishana Kumar Chaturvedi was appointed as Team Leader cum Sr. Highway Engineer by M/s Arkitechno Consultants (India) Pvt. Ltd. (JV) with G Eng Advisory Services Private Limited for the work of Consultancy Services for Authority Engineer for supervision of (i) Rehabilitation and Up-gradation of road from design Km 0.00 to Km 36.460 (Pkg-I, II & III) of Kailashahar-Kurti Bridge section of NH-208A to two lane with paved shoulder (ii) Rehabilitation and Up-gradation of road from design Km 0.000 to Km 18.600 of Kumarghart-Kailashahar Section of NH-208 to two lane with paved shoulder in the state of Tripura on EPC mode.

2. Sh. Krishana Kumar Chaturvedi vide letter dated 07.10.2021 recommended/ certified for wrong payment of SPS-04 for the work of Pkg -II of NH-208A. Further, Sh. Krishana Kumar Chaturvedi has resigned in the middle of project. He was served a show cause notice by GM (P) PMU NHIDCl Dharmamnagar. The Team Leader has replied to the "Show Cause Notice" in which it is evident that the Team Leader has resigned in the middle of the project due to his health and personnel reasons and in addition there is also an admittance of "Wrong Certification of payment" of his reply. Therefore, the reply furnished by him is not found satisfactory.

3. Therefore, as per the stipulation in Clause no. 4.5.6 of GCC of Contract Agreement and MoRT&H circular dated 07.10.2021, Sh. Krishana Kumar Chaturvedi is hereby debarred/ blacklisted from participating in future MoRT&H or its Executing Agencies projects for a period of 1 years from the date of issue of this notice.
