Surya Bhushan Singh was appointed as Senior Quality cum Material Expert by M/s Chaitanya Project Consultancy Pvt. Ltd. in association with MPG Engineering Consultancy Pvt. Ltd. for the work of Consultancy Service for Authority's Engineer for Supervision of (i) Construction/ up-gradation of existing road to 2-lane with Paved shoulder from km 40.00 (Kafer) to km 61.100 (Lava More) of the Kafer to Reshi border section of NH-717A on EPC Basis under SARDP-NE Phase A in the State of West Bengal (PKG-VA) & (ii) construction and up-gradation of existing road to 2 lane with paved shoulder including geometric improvement of section from start of Pedong bypass to Reshi border of NH-717A from km 79.700 to km 96.254 on EPC basis on SARDP-NE Phase-A in the State of West Bengal (PKG-VB).
