AMENDMENT TO THE DEBARMENT LETTER DATED 18.02.2019

National Highways & Infrastructure Development Corporation Ltd., vide its letter No. NHIDCL/CivilWork/ALT/Bagrakot-Kafer/PKG-IVA/2017/117 dated 18.02.2019 debarred the following companies, jointly and severally for a period of 2 (two) years from participating directly or indirectly in any form in any work connected with NHIDCL under the provisions of clause 4.2 of section 4 of the RFP document:

2. M/s S&P Infrastructure Developers Pvt. Ltd., by way of Writ Petition (C) No. 2130/2019 titled as M/s S&P Infrastructure Developers Pvt. Ltd. Vs National Highways & Infrastructure Development Corporation Limited, impugned the debarment letter dated 18.02.2019 before the Hon'ble High Court of Delhi at New Delhi. The Hon'ble High Court vide its judgment dated 01.07.2019 allowed the petition filed by M/s S&P Infrastructure Developers (P) Ltd., and passed the following direction:

“52. In view of the above, the petition is allowed and the impugned order to the extent it debar the petitioner for a period of two years, is set aside. The pending applications are also disposed of.”

3. In view of the judgment dated 01.07.2019, the letter of debarment dated 18.02.2019 is amended to the extent that the M/s S & P Infrastructure Developers Pvt. Ltd. would not be held to be debarred thereunder.

It shall be subject to alteration if Hon'ble Court at a later date decides otherwise.
