

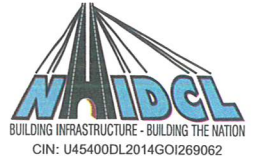

DEBARMENT ORDER

Sub: Debarment of Sh. G. S. Bansal from engagement on NHIDCL/MoRT&H projects for a period of 01 (One) year.

It is brought to notice of all the Divisions/Units of NHIDCL and other agencies of MoRT&H that Sh. G. S Bansal was appointed as "Team Leader" by M/s Yongma Engineering Co. Ltd. and M/s Techniko Consultancy Services Pvt. Ltd. for the work of "Consultancy Services for Authority's Engineer and Engineer In- Charge as Applicable for Km 0.00 To Km 330.70 of Andaman Trunk Road in the Union Territory of Andaman & Nicobar Islands for EPC Contracts Packages (Total Length 177.85 Km) and Item Rates Contracts (Total Length= 64.40 Km) respectively".

2. Sh. G. S Bansal left the assignment without prior approval of the Employer, i.e., NHIDCL. He was served a Show Cause Notice by NHIDCL RO-Sri Vijaya Puram vide letter no. 181 dated 16.07.2024 asking him to furnish reply within 15 days. The reply submitted by Sh. G.S Bansal is not satisfactory.

3. Clause 11.2 of TOR of Contract Agreement reads that *"In case the key personnel leave the assignment without approval of Employer, Employer would be at liberty to take any appropriate action against those key personnel including debarment"*

4. Therefore, as per Clause 11.2 of TOR, Sh. G. S Bansal is hereby debarred for a period of 01 (One) year from engagement in NHIDCL/MoRT&H projects or to be undertaken by it either directly or indirectly effective from the date of issue of this order.
