**CIRCULAR**

**Subject:** Debarment of Sh. Rajeev Kumar from engagement on NHIDCL/MORT&H projects for 0.5 year (6 months).

It is brought to notice of all the Divisions/Units of NHIDCL and other agencies of MoRT&H that Sh. Rajeev Kumar was appointed as "Senior Quality cum Material Engineer" by M/s Planning & Infrastructural Development Consultants Pvt. Ltd for the work of Consultancy Services for Authority's Engineer for Supervision of (i) Construction of 2 lane with hard shoulder of Kohima – Jessami road on NH- 29 from existing Km 76.32 (Near Mesulumi Village) to existing Km 98.38 (Near Chizami Village) (Design Length 21.50 Km) under Bharatmala Pariyojana on EPC mode (Package-IV) and (ii) Construction of 2 lane with hard shoulder of Kohima – Jessami road on NH- 29 from existing Km 98.38 (Near Chizami Village) to existing Km 120.367 (Nagaland/Manipur Border) (Design Km 97.70 to Km 117.20) Design Length 21.50 Km under Bharatmala Pariyojana on EPC mode(Package-V).

2. Sh. Rajeev Kumar has left the subject project before the scheduled completion, thereby violating the GCC clause 4.5.6 of the Contract Agreement.

3. Therefore, as per stipulations of the GCC clause 4.5.6 of the Contract Agreement, Sh. Rajeev Kumar is hereby debarred for 0.5 year (6 months) from engagement on NHIDCL/MORT&H's project of/or to be undertaken by it either directly or indirectly effective from the date of this circular.
