It is brought to notice of all the Divisions/Units of NHIDCL and other agencies of MoRT&H that Sh. Mohammed Noushad Siddique was appointed as "Bridge/Structural Engineer" by M/s Austha Engineering Consulting Pvt. Ltd. in JV with DN Consultant for the work of Consultancy Services for Authority's Engineer for Supervision of "Improvement/widening to 2-lane with Earthen Shoulder of Ranikor-Maheshkhola-Baghmara road section: (i) **Package-IV** from Kanai to Rongara existing Ch. from 85+970 to Ch.102+345 (design Ch. 81+100 to 96+000) design length-14.763 Km and (ii) **Package-V** from Km 102+345 to Km 119+810 (design Ch. 96+000 to 112+300) design length-16.30 Km, on EPC mode under SARDP-NE Phase-A in the state of Meghalaya."

2. Sh. Mohammed Noushad Siddique had left the assignment before the scheduled completion of the project without the approval of the Employer, i.e. NHIDCL. Also, AE informed the Authority vide letter dated 17.04.2021 that Sh. Mohammed Noushad Siddique did not respond to any communication over email/phone.

3. Therefore, as per stipulations in Clause 4.5.6 of the GCC and Clause 12.2 of the TOR of the Contract Agreement, Sh. Mohammed Noushad Siddique is hereby debarred for a period of one year for engagement on MoRT&H NHIDCL/NHAI's project of/or to be undertaken by it either directly or indirectly effective from the date of this circular.
