Sub: Restoration/Rehabilitation of Imphal to Jiribam road of NH-37 (old NH-53) from Km 145.350 to Km 158.618 in the state of Manipur-reg.

The tender for the subject work was invited having Bid Due Date on 07.12.2020. M/s Satya Builders participated in the bidding process and uploaded the bids for the subject work on CPPP website.

2. Whereas, M/s Satya Builders vide letter dated 09.12.2020 (Annexure-I) has requested not to consider the bid submitted by them for technical evaluation and requested to withdraw the bid with immediate effect.

3. Whereas, in regard to the withdrawal of bid by M/s Satya Builders, clause 2.20.1 of Section 2 of RFP document may be referred, which states that;

## Bid Securing Declaration:

"The Bidder has to sign a Bid securing declaration accepting that if the bidder withdraw or modify its bid during the period of validity i.e. not less than 180 (one hundred eighty) days from the bid due date or if the bidder is awarded the contract and fail to sign the contract or to submit a performance security before the deadline defined in the request of the bid documents, the bidder will be debarred for participation in the tendering process for the works of NHIDCL and works under other Centrally Sponsored Scheme, for a period of one year from the bid due date of this work. The bid securing declaration shall be submitted as per the format at Appendix-II (Format for Bid Securing Declaration). A scanned copy of the Did Securing Declaration shall be uploaded while applying to the 4. Whereas, M/s Satya Builders had submitted the *Bid Securing Declaration* along with the bid in pursuant to Clause 2.20.1 of Section 2 of RFP (copy enclosed). Further, M/s Satya Builders represented its case vide letter date 17.12.2020 & 18.12.2020 wherein they had submitted that they has not considered the corrigendum no.-II wherein the amount of additional performance security was modified. Hence, it was requested by them to consider their bid as per the RFP document and not as per the modified provisions as stated in the Corrigendum no.-II. The same has not been accepted by the Competent Authority.

5. In view of all above, M/s Satya Builders is hereby debarred from participating in any tendering process for the works of NHIDCL and works under other Centrally Sponsored Scheme in pursuant to clause 2.20.1 of Section -2 of the RFP document for a period of one year from the bid due date i.e. 07.12.2020 till 06.12.2021.

6. This letter is issued without prejudice to any other right or remedy available to the Authority under the RFP document and/or applicable law and is issued with the approval of the Competent Authority, NHIDCL.
