**DEBARMENT NOTICE**

**Sub: Debarment of Mr. Arun Kumar and Mr. Ram Kailash Yadav from the engagement of MoRT&H/NHIDCL/NHAI projects for a period of 02 Years-Regd.**

It is brought to the notice of all the implementing agencies of the Ministry that Mr. Arun Kumar was selected as Team Leader cum Senior Highway Engineer and Mr. Ram Kailash Yadav was selected as Bridge/Structural Engineer by M/s L. N. Malviya Infra Projects Pvt. Ltd. for the work "Independent Engineer Services for Improvement and upgradation to Four Lane with Paved Shoulder configuration from Existing Km. 0+000 to Km. 39+500 (Design Ch.- (0+500) to Ch. 40+342, Design length 40+842 Km) of NH 227A (near Mehrauna Ghat (UP-Bihar Border) to Siwan) in the State of Bihar on Hybrid Annuity Mode."

2. In this regard, it is to mention that inspite of confirmation of participation in the subject consultancy work, following the consent and interaction with MoRTH authorities, Sh. Arun Kumar, Team Leader cum Senior Highway Engineer has not reported to the site & declined to join the project. Also, Sh. Ram Kailash Yadav, Bridge/Structural Engineer has been absent and unavailable since the commencement of his duties at the project site.

Therefore, as per Clause 4.5.2 & 4.5.6 of General Conditions of Contract of RFP, Mr. Arun Kumar, Team Leader cum Senior Highway Engineer and Mr. Ram Kailash Yadav, Bridge/Structural Engineer are hereby debarred from participating in future projects of Ministry and its executing agencies for a period of 2 years from the date of issue of this notice.
