Sub: Debarment of **Mr. Bikash Prasad Gupta** from engagement in NHIDCL/MoRTH Projects for a period of 02 years.

It is hereby intimated to all the divisions/units of NHIDCL and other agencies of MoRTH that **Mr. Bikash Prasad Gupta** was selected as the **Resident cum Highway Engineer** by M/s Lion Engineering Consultants Pvt. Ltd. in association with M/s Rudrabhishek Enterprises Limited for the work **Consultancy services for Authority's Engineer for Supervision of:** (i) Widening and Improvement of Imphal-Moreh section of NH-39 from Km 395.680 to Km 425.411 to Two (2) lane with paved shoulders configuration in the State of Manipur (Package-III) on Engineering, Procurement & Construction (EPC) mode under ADB(SASEC) loan under Tranche-3. (ii) Construction of Moreh Bypass to Two lane with paved shoulder from km 421.950 to km 425.411 (Length: 2.52 km) on NH-39 near Indo Myanmar border in the State of Manipur on EPC. (iii) Widening/Strengthening to Two laning with hard shoulder of Pallel – Chandel section from km 0+000 to km 18+292 of NH-102C in the state of Manipur on Engineering, Procurement & Construction (EPC) Mode


2. NHIDCL, RO-Imphal vide letter 23 dated 06.04.2022 has informed that **Mr. Bikash Prasad Gupta** has shown un-professional behavior during supervision and monitoring of the project and accordingly the services of **Mr. Bikash Prasad Gupta** has been terminated by the Consultancy firm.

3. Therefore, as per stipulation of the GCC Clause 4.5.6 of Contract Agreement, **Mr. Bikash Prasad Gupta** is hereby debarred/blacklisted from participating in future projects of NHIDCL/MoRTH executive agencies for a period of 02 years from the date of issue of this notice.
