## DEBARMENT NOTICE

**Subject:** Debarment of Mr. Anil kumar Pandey from engagement on NHIDCL/MORT&H projects for 2 Years.

It is brought to notice of all the Divisions/Units of NHIDCL and other agencies of MoRT&H that Mr. Anil kumar Pandey was appointed as "Resident cum Highway Engineer" M/s Global Infra Solutions Association Infycons Creative Software Pvt. Ltd. for the work of "Consultancy services for Authority's Engineer for Supervision of: (i) Construction of two lane with hard shoulders of Arrowa-Khupa-Hayuliang Section of NH-113 from Ch 68.550 Km to 91.633 in the state of Arunachal Pradesh on EPC Mode under NH(O)-NE. (ii) Construction of two lane with hard shoulders of Demwe-Brahmkund section of NH-13 from Ch 0.000 Km to 18.464 in the state of Arunachal Pradesh on EPC Mode under NH(O)-NE."

2. Mr. Anil kumar Pandey has shown his inability to complete the assignment after providing his consent for his availability for the entire duration of the subject project, thereby violating the Clause 4.5.2 of General Conditions of Contract Agreement.

3. Therefore, as per stipulations of the Clause 4.5.2 of the Contract Agreement, Mr. Anil kumar Pandey is hereby debarred for 2 years (24 months) from engagement on NHIDCL/MORT&H's project of/or to be undertaken by it either directly or indirectly effective from the date of this circular.
