## DEBARMENT NOTICE

**Subject:** Debarment of Mr. Hemant Tiple from engagement on NHIDCL/MORT&H projects for 2 Years.

It is brought to notice of all the Divisions/Units of NHIDCL and other agencies of MoRT&H that Mr. Hemant Tiple was appointed as "Senior Quality Cum Materials Engineer" M/s BLOOM JV M/s Jindal Association with M/s Kapil Muni Infra Projects Pvt. Ltd. for the work of Consultancy Services for Authority's Engineer for supervision of "(i) Construction of High Altitude Hill Road from Tedadege to Henkaer from KM 0.000 to KM 28.550 in West Siang District of the state of Arunachal Pradesh on EPC Mode. (ii) Construction of High Altitude Hill Road from Doginala to Gau from KM 0.000 to KM 15.320 in Upper Subansiri District of the state of Arunachal Pradesh on EPC Mode."

2. Mr. Hemant Tiple has left the assignment in the middle of the work citing health issues and has not submitted any valid/justified documents after providing his consent for his availability for the entire duration of the subject project, thereby violating the Clause 4.5.2 of General Conditions of Contract Agreement.

3. Therefore, as per stipulations of the Clause 4.5.2 of the Contract Agreement, Mr. Hemant Tiple is hereby debarred for 2 years (24 months) from engagement on NHIDCL/MORT&H's project of/or to be undertaken by it either directly or indirectly effective from the date of this circular.
