Ltd, in JV with M/s Armenge Engg. & Management Consultants Pvt. Ltd. for the work Consultancy Services for Authority's Engineer for Supervision of "Widening/Improvement to 4-lane with paved shoulder for Daboka-Khatkhathi stretch of NH-29 of Package-5 starting from Near Ganpath Gaur Gaon at Km 95+400 to Kwaram Tero Village at Km 113+330 (Design Km 96+400 to Km 113+830) in the State of Assam on EPC Mode."

2. M/s Feedback Infra Pvt. Ltd, in JV with M/s Armenge Engg. & Management Consultants Pvt. Ltd. vide letter no. 2363 dated 27.01.2022 has informed that Mr. Maithili Sharan has refuse to join the assignment.
